This program consists of twenty-one (21) classroom sessions (seven hours per session) and is designed to give the student the skills and knowledge to function as a working Emergency Medical Technician at a basic level and to facilitate the passing of the National Registry Exam. All equipment required for the course of study such as stethoscopes, blood pressure cuffs, splinting devices and spinal boards will be provided by the school at no cost to the student. The program is intended for those who want to gain employment as a firefighter, emergency care technician at a hospital, as an ambulance driver or attendant. It is also for those individuals who are planning on attempting to obtain a higher level of medical training such as RN, PA or MD as an enhancement for the competitive application process for those professions.

Cancellation and refund policy: STUDENT'S RIGHT TO CANCEL

Students are required to submit a two-hundred-dollar (\$250.00) registration fee as a condition of registration for the Initial Certification Program for EMT-Basic. Cancellation of attendance in this program will allow the student a full refund only if cancellation is made Ten (10) working days prior to the start date of the class in which the student has registered. If cancellation is made less than ten working days prior to the start date of the course, the registration fee is considered non-refundable. Cancellation is defined as sending a date verifiable e-mail to the CIEMT course program directors e-mail address. Student Services:

Student services at the CIEMT consist of both a reference library and online web access at the school, to broaden student research options. If necessary, academic counseling will be provided at no cost to the student at the start of the second week and third week of the Initial Certification Program for Emergency Medical Technician course. The need for counseling and subsequent tutorial recommendations will be determined by a thorough review of both academic grades on daily quizzes and practical skills performance evaluation. Tutoring will be available for a nominal fee (\$15 per Hour) by qualified CIEMT instructors, approved and designated by the program director. All other required material including the EMS policies guide to Los Angeles County scope of practice will be provided by the CIEMT at no additional cost to the student.

The CIEMT refund policy for the unused portion of tuition fees: Students who withdraw from the Initial Certification Program for EMT and have completed 60 percent or less of the course a refund shall be calculated as follows: (if the student has attended more than 60 percent of the course no refund will be due.)

- 1. A registration fee of \$250 dollars will be deducted from the total tuition.
- 2. The remaining figure will be divided by the number of hours in the program.
- 3. The sum arrived at through the calculations of #2 is the hourly charge for the program.
- 4. The amount owed by the student for the purposes of calculating a refund is derived by multiplying the total hours of instruction by the hourly charge for instruction plus the amount of the registration fee.
- 5. The refund shall be any amount in excess of the figure derived in #4 that was paid by the student.
- 6. If the student has attended greater than 60% of the CIEMT EMT-Basic course tuition will not be refunded.
- 7. The student must exercise his or her right to cancel or withdraw before attending skills day 2. For your EMT program the date will be ______25

Example: If a student withdraws from the CIEMT EMT course after attending 75 hours of program, the refund of tuition would be calculated as follows:

- 1. \$1110.00 Course Fee \$0 STRF \$250.00 Registration Fee =\$860.00
- 2. \$860.00 divided by the number of hours in the program 146 Hrs. = \$5.89 an hourly charge for the program.
- 3. The amount owed by the student would be the hours in which the student attended the course 75 hours X the hourly charge \$5.89 = \$441.75 plus the registration fee of \$250.00 equaling a student owed amount of \$691.75
- 4. The amount in excess and refund to the student would be tuition amount \$1110.00 \$691.75 the amount owed by the student, which would equal a refund amount paid to the student of \$418.25.

If the institution sent the first lesson and materials before an effective cancellation notice was received, the institution shall make a refund within 45 days after the student's return of the materials.

Student Tuition Recovery Fund

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

(b) In addition to the statement required under subdivision (a) of this section, a qualifying institution shall include the following statement in its school catalog: "It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- 1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- 2. You were enrolled at an institution or a location of the institution within the 120-day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120-day period before the program was discontinued.
- 3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
- 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- 5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- 6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.

7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery.

If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number."

If the Student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds. Cancellation or withdraw from the program is defined as ether directly speaking to the CIEMT course program director or sending a date verifiable e-mail to the CIEMT course program directors e-mail address. If the student is eligible for a student loan and the student defaults on a **federal or state** loan, both of the following may occur: The federal or state government or loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan. - "On-time Completion Rate" is the number of on-time graduates divided by the number of students available for graduation.
- "150% Graduates" is the number of students who completed the program within 150% of the program length (includes on-time graduates).
- "150% Completion Rate" is the number of students who completed the program in the reported calendar year within 150% of the published program length, including on-time graduates, divided by the number of students available for graduation.
- "Graduates Available for Employment" means the number of graduates minus the number of graduates unavailable for employment.
- "Graduates Unavailable for Employment" means the graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- "Graduates Employed in the Field" means graduates who beginning within six months after a student completes the
 applicable educational program are gainfully employed, whose employment has been reported, and for whom the
 institution has documented verification of employment. For occupations for which the state requires passing an
 examination, the six months period begins after the announcement of the examination results for the first examination available
 after a student completes an applicable educational program.
- "Placement Rate Employed in the Field" is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- "Number of Graduates Taking Exam" is the number of graduates who took the first available exam in the reported calendar year.
- "First Available Exam Date" is the date for the first available exam after a student completed a program.
- "Passage Rate" is calculated by dividing the number of graduates who passed the exam by the number of graduates who took the reported licensing exam.
- "Number Who Passed First Available Exam" is the number of graduates who took and passed the first available licensing exam after completing the program.
- "Salary" is as reported by graduate or graduate's employer.
- "No Salary Information Reported" is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.

Attendance/Testing Standards/Rules and Regulations

This is an accelerated course and course content is cumulative in nature, there is little room for tolerance when it comes to students being absent. CIEMT allows a student to be absent for only one (1) course class, with the condition that that class is made up by the student. There are (6) classes which attendance are mandatory (all skills classes and review days). Make-up classes will be given by approved CIEMT tutors only, the cost of which will be paid by the student (\$40.00 per hour) at the time the makeup class is given. The second absence or missing any mandatory day will be cause for dismissal from the course. If you are more than one hour late for a non-mandatory lecture class it will be calculated as the student's one allowable missed class and only the time missed must be made up in full at the students own expense. If you are more than 15 min late for a skills day you must make up the skills you missed with private tutoring. More than 30 min late for a skills day is cause for dismissal from the program. Use of cell phones or text messaging during class time is strictly prohibited. If you are caught using your cell phone you will be ask to leave immediately. If one of the above infractions occurs during one of the 6 mandatory days of course attendance it is cause for dismissal from the course. CIEMT is a no tolerance school when it comes to violence and sexual harassment. Any violence or documented sexual harassment directed toward instructors or students is cause for dismissal.

Pass/Fail Standards on Quizzes: All students will be required to achieve a cumulative score of 80% on all quizzes in order to qualify to take the final exam. All Students must complete the FEMA ICS 100 & 700 and hand in the completion certificates by skills days 2 of the program.

Pass/Fail Standard on Tests: All students will be required to score an 80% or higher to qualify for a completion certificate.

Pass/Fail Standards on Skills Examinations: All students must have passing marks on all skills in order to qualify to take the final skills exam. The weekly skills course evaluation sheets must be signed and dated by an Associate Instructor or Program Director for each skill attempted. Every student will be required to pass the final skills examinations with 100% proficiency. The standard of 100% proficiency will be graded by evaluation and monitoring of skill time limits and critical criteria for each skill. The student will be allowed 10 minutes to successfully complete each skill. Critical criteria are a list of actions that must be avoided in order for the student to pass his/her final skills exam. All students are provided with comprehensive L.A. County list of critical criteria for each skill that must be avoided during final skill testing in there CIEMT personnel dashboard they receive when they register and pay for a program.

Makeup Procedures for Quizzes and Tests: All students will be allowed 5 (five) makeup quizzes. Makeups are only for quizzes that were graded below the 80% pass requirement. Quiz makeups will be given 30 min before class begins on any day prior to day 20 (final written testing day). Only two Quizzes can be taken on any given day. There is no charge for makeup quizzes. All students will be allowed 1 (one) makeup final exam. The makeup final written exam will not be re-administered on the same day as the failed final exam. The written final makeup exam must be taken no later than 4 days after then original failed final exam was administered. The student will incur a testing fee of \$80.00 for the second final written exam. The student will be allowed to re-take 3 failed skills at no charge. These skills must be retaken on the final skills testing day. If the student fails a fourth skill or any skill twice he/she will have failed out of the program.

Performance standards for clinical and/or ambulance experience

- 1. Students must complete a minimum of **24** hours of clinical and/or ambulance experience.
- 2. Students must have a minimum of **10** patient contacts
- 3. A qualified preceptor must evaluate all Patient contacts.
- 4. A valid acceptable "patient contact" must include the following performance by the student for each patient:
- A. Patient Assessment
- B. Patient vitals (B/P, Pulse, Respiratory rate)
- 5. A valid acceptable "patient contact" must include the following information documented for each patient:
- A. Chief complaint
- B. Age/sex of the patient
- C. Patient Hx. If possible (SAMPLE/OPQRST/ASPN)
- D. Skills performed by the student
- 6. Students must have successfully completed a Health Care Professional or Professional Rescuer CPR program prior to beginning clinical and/or ambulance experience. Student must have their card with them during the ride out.
- 7. **Dress Code:** All students are to report to their assigned stations wearing dark pants (black or blue) a white shirt, and black shoes. All body piercing must be removed and hair pulled back and secured (if needed). There are no exceptions to the dress code rules! If a student reports to their station unprepared they will be refused access to the ride-along and told to go home.
- 8. All evaluation forms must be completed and signed by the student's preceptor just prior to the completion of the ride-along shift. If it does not have an official preceptor signature your ride-along didn't happen. <u>Be</u> aware that your ride-along is on a working ambulance that is conducting business and administering patient care to real patients. You must be professional at all times and complete all calls. This may require you to stay beyond the mandatory 24 hours if your preceptor is in the middle of a call.



Commonly Asked Criminal Background Questions

- 1. Which criminal offenses **WILL** exclude an applicant from being eligible for EMT Certification?
 - Has been convicted of any sexually related offense specified under Section 290 of the Penal Code
 - Has been convicted of murder, attempted murder, or murder for hire
 - Has been convicted of two (2) or more felonies
 - Is on parole or probation for any felony
 - Has been convicted and released from incarceration for offenses during the preceding fifteen (15) years for the crime of manslaughter or involuntary manslaughter
 - Has been convicted and released from incarceration during the preceding ten (10) years for any offense punishable as a felony
 - Has been convicted of two (2) or more misdemeanors within the preceding five (5) years for any offense relating to the use, sales, possession, or transportation of narcotics or addictive or dangerous drugs.
 - Has been convicted of two (2) or more misdemeanors within the preceding five (5) years for any offense relating to force, threat, violence, or intimidation
 - Has been convicted within the preceding five (5) years of any theft related misdemeanor
- 2. Which criminal offenses **MAY** exclude an applicant from being eligible for EMT Certification?
 - Has committed any act involving fraud, intentional dishonesty for personal gain within the preceding seven (7) years
 - Is required to register pursuant to Section 11590 (Controlled Substance Offender) of the Health and Safety Code
 - Conviction of one (1) misdemeanor within the last five (5) years for a related offense listed within the Health and Safety Code, Section 1798.200



Health and Safety Code Violations 1798.200

Any of the following actions shall be considered evidence of a threat to public health and safety <u>and</u> <u>may result in denial, suspension, or revocation of a certificate or license, or in the placement on</u> <u>probation of a certificate or license holder under this division:</u>

- 1. Fraud in the procurement of any certificate or license.
- 2. Gross negligence.
- 3. Repeated negligent acts.
- 4. Incompetence.
- 5. The commission of any fraudulent, dishonest, or corrupt act that is substantially related to the qualifications, functions, and duties of prehospital personnel.
- 6. Conviction of any crime that is substantially related to the qualifications, functions, and duties of prehospital personnel. The record of conviction or a certified copy of the record of conviction shall be considered conclusive evidence of the conviction.
- 7. Violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provision of this division or the regulations adoptedby the authority pertaining to prehospital personnel.
- 8. Violating or attempting to violate any federal or state statute or regulation that regulates narcotics, dangerous drugs, or controlled substances.
- 9. Addiction to, the excessive use of, or the misuse of, alcoholic beverages, narcotics, dangerous drugs, or controlled substances.
- 10. Functioning outside the supervision of medical control in the field care system operating at the local level, except as authorized by any other license or certification.
- 11. Demonstration of irrational behavior or occurrence of a physical disability to the extent that a reasonable and prudent person would have reasonable cause to believe that the ability to perform the duties normally expected may be impaired
- 12. Unprofessional conduct exhibited by any of the followings:
 - o Mistreatment or physical abuse of any patient resulting from excess force in excess of what a reasonable and prudent person trained in a similar capacity would use
 - o Failure to maintain confidentiality
 - o The commission of any sexually related offense under Section 290 PC
