#### Cancellation and refund policy: STUDENT'S RIGHT TO CANCEL

Students must submit a two hundred dollars and fifty (\$250.00) registration fee as a condition of registration for the Hybrid for EMT Program. Cancellation will provide the student a full refund only if cancellation is made before the first lesson and material are received. If cancellation is made after the first lesion and materials are received for the course, the registration fee (\$250.00) is considered non-refundable. Cancellation is effective on the date written notice of cancellation is sent. You may send a date verifiable e-mail to the CIEMT course program directors e-mail address. If the provisions of cancellation described herein are not met the **registration fee is considered non-refundable**. An institution offering a distance educational program where the instruction is not offered in real time shall transmit the first lesson and any materials to any student within seven days after the institution accepts the student for admission. The student shall have the right to cancel the enrollment agreement and receive a full refund before the first lesson and materials are received. Cancellation is effective on the date written notice of cancellation is sent. The institution shall make the refund pursuant to section 71750 of the Regulations. #### **Student Services:**

If necessary, academic counseling will be provided at no cost to the student at the start of the second week and third week of the Initial Certification Program for the Hybrid Emergency Medical Technician course. The need for counseling and subsequent tutorial recommendations will be determined by a thorough review of both academic grades on daily quizzes and practical skills performance evaluation. Tutoring will be available for a nominal fee by qualified CIEMT instructors, approved and designated by the program director. - 3. The remaining figure will be divided by the number of expected hours spent in the program. Each "Section" of the Hybrid EMT Program will be assigned a number of hours based upon estimated time needed to complete each section. The course consists of 183 hours of instruction over a 10-week period. You will spend on average 18.3 hours per week or 2.61 hours per day.
- 4. The sum arrived at through the calculation of #2 is the cost per hour for the training.
- 5. The amount owed by the student is derived by multiplying the total expected hours spent in the Hybrid program by the hourly charge for instruction plus the amount of the registration fee and materials fee.
- 6. The refund shall be any amount in excess of the figure derived in #4.
- 7. The student must exercise his or her right to cancel or withdraw before 60% of the Hybrid EMT Program is completed.
- 8. The student must exercise his or her right to cancel or withdraw before attending skills day 2. For your EMT program the date will be 26

Example: A student withdraws from the CIEMT HYBRID EMT course on Friday of Week 5 in the course. This is day 33 of the course or 86.1 hours into the course. The refund of tuition would be calculated as follows:

- 1. \$1161.06 Course Fee \$0 STRF \$250.00 Registration Fee =\$911.06
- 2. \$911.06 divided by the number of hours in the program 179 Hrs. = \$5.08 per hour.
- 3. The amount owed by the student would be 86.1 hours X the hourly rate of \$5.08 = \$437.38 plus the registration fee of \$250.00 equaling a student owed amount of \$687.38
- 4. The amount in excess and refund to the student would be tuition amount \$1161.06 \$687.38 the amount owed by the student, which would equal a refund amount paid to the student of \$473.68

**Note**: Students that reach the 60 percent point (by the start of Skill Session #2) in the Hybrid EMT Program will receive no refund. #### **Student Tuition Recovery Fund**

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- 1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- 2. You were enrolled at an institution or a location of the institution within the 120-day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120-day period before the program was discontinued.
- 3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.

- 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- 5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required bylaw, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- 6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
- 7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans. To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollecting may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery.

If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number."

If the Student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds. Cancellation or withdraw from the program is defined as ether directly speaking to the CIEMT course program director or sending a date verifiable e-mail to the CIEMT course program directors e-mail address. If the provisions of cancellation described herein are not met the deposit is considered non-refundable. The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid. Attendance/Testing Standards/Rules and Regulations

This is a Hybrid course and content is cumulative in nature. To succeed, students must keep up with the online course work and attend all assigned Skill Days and Online classroom sessions. While online work can be done at the students chosen time, attendance for all of the Skill Days and Online classroom sessions is MANDATORY! Students MUST ARRANGE THEIR SCHEDULE TO ATTEND THESE MANDATORY SESSIONS.

- A. Missing any of the Skill Days will result in being dismissed from the course. Being more than 30 minutes late for a Skill Day is considered missing the entire day and will result in dismissal from the Hybrid EMT Program.
- B. Use of cell phones or text messaging during class time is strictly prohibited. Using a cell phone during Instructional time on either the Skill Days (except at scheduled breaks) will result in you being dropped from the Hybrid EMT Program.
- C. CIEMT is a no tolerance school when it comes to violence and sexual harassment. Any violence or documented sexual harassment directed toward instructors or students is cause for dismissal.

<u>Leave-of-absence Policy</u>: Because of the nature of the course, students are not allowed a leave-of –absence. If something occurs and the student is not able to complete the course they are enrolled in, they can drop the class and receive their pro-rated refund if they drop before the 60% point in the course.

**<u>Dress code in class</u>**: No flip flops and no short dresses on skills days.

**Dismissal Policies:** If a student is absent for one of the Skill Days they will be dismissed from the program. If the absence occurs prior to the 60% of the course the student will be issued a prorated refund. If the absence occurs after the refund cut off day, no refund will be issued. If the student is dismissed for using a cell phone during class time, documented violence and/or sexual harassment, the above refund policy will apply. An absence will be defined as being more than 30 minutes late for a Skill Day.

#### **Grading Policy for the Hybrid EMT Course**

Pass/Fail Standards on Quizzes: All students will be required to have at least an 80% quiz average in order to qualify to take the Final Written Exam. All quizzes are online in the Hybrid EMT Course and can be retaken multiple times in order to pass them. Section Tests are also online and only 1 retake is allowed on each Section Test. All section test must be completed during the prescribed open period designated for those specific section test. Failure to complete all section test during the prescribed time for those exams may result in dismissal from the course. FEMA ICS 100 & 700 certificates must be submitted by skills day 2 of the program.

<u>Pass/Fail Standard on Final Written Test</u>: All students will be required to score 80% or higher on the Final Written test (held at one of the CIEMT campuses) and successfully pass the Final Practical exam to receive a Certificate of Completion for the EMT Course. One re-take of the final written is allowed if needed only if the student passes the practical exam.

Pass/Fail Standards on Skills Examinations: All students will be required to pass the final skills examinations with 100% proficiency. The standard of 100% proficiency will be graded by evaluation and monitoring of skill time limits and critical criteria for each skill. The student will be allowed 10 minutes to successfully complete each skill. Critical action are a list of actions that must be performed in order for the student to pass his/her final skills exam. Critical action for each skill will be based on the Critical action outlined in Los Angeles County EMS Skills evaluation sheets. Students are allowed to fail 3 skills and will receive one retest on each. If the students fails a skills twice or a 4<sup>th</sup> skills they will be dismissed from the course.

<u>Makeup Procedures for Quizzes and</u> Tests: All students will be allowed 1 (one) retake on the Final Written Exam. The makeup Final Written Exam will not be re-administered on the same day as the failed Final Written Exam. The Final Written Exam retake exam must however, be taken no later than 7 days after the date they failed the original Final Written Exam. Dates available will be submitted to the student by school administration. There is an \$80.00 Retake fee for the Final Written Exam.

#### Performance standards for clinical and/or ambulance experience

- 1. Students must complete a minimum of **24** hours of clinical and/or ambulance experience.
- 2. Students must have a minimum of **10** patient contacts
- 3. A qualified preceptor must evaluate all Patient contacts.
- 4. A valid acceptable "patient contact" must include the following performance by the student for each patient:
- A. Patient Assessment
- B. Patient vitals (B/P, Pulse, Respiratory rate)
- 5. A valid acceptable "patient contact" must include the following information documented for each patient:
- A. Chief complaint
- B. Age/sex of the patient
- C. Patient Hx. If possible (SAMPLE/OPQRST/ASPN)
- D. Skills performed by the student
- 6. Students must have successfully completed a Health Care Professional or Professional Rescuer CPR program prior to beginning clinical and/or ambulance experience. Student must have their card with them during the ride out.
- 7. **Dress Code:** All students are to report to their assigned stations wearing dark pants (black or blue) a white shirt, and black shoes. All body piercing must be removed and hair pulled back and secured (if needed). There are no exceptions to the dress code rules! If a student reports to their station unprepared they will be refused access to the ride-along and told to go home.
- 8. All evaluation forms must be completed and signed by the student's preceptor just prior to the completion of the ride-along shift. If it does not have an official preceptor signature your ride-along didn't happen. Be aware that your ride-along is on a working ambulance that is conducting business and administering patient care to real patients. You must be professional at all times and complete all calls. This may require you to stay beyond the mandatory 24 hours if your preceptor is in the middle of a call.



## Commonly Asked Criminal Background Questions

- 1. Which criminal offenses **WILL** exclude an applicant from being eligible for EMT Certification?
  - Has been convicted of any sexually related offense specified under Section 290 of the Penal Code
  - Has been convicted of murder, attempted murder, or murder for hire
  - Has been convicted of two (2) or more felonies
  - Is on parole or probation for any felony
  - Has been convicted and released from incarceration for offenses during the preceding fifteen (15) years for the crime of manslaughter or involuntary manslaughter
  - Has been convicted and released from incarceration during the preceding ten (10) years for any offense punishable as a felony
  - Has been convicted of two (2) or more misdemeanors within the preceding five (5) years for any offense relating to the use, sales, possession, or transportation of narcotics or addictive or dangerous drugs.
  - Has been convicted of two (2) or more misdemeanors within the preceding five (5) years for any offense relating to force, threat, violence, or intimidation
  - Has been convicted within the preceding five (5) years of any theft related misdemeanor
- 2. Which criminal offenses MAY exclude an applicant from being eligible for EMT Certification?
  - Has committed any act involving fraud, intentional dishonesty for personal gain within the preceding seven (7) years
  - Is required to register pursuant to Section 11590 (Controlled Substance Offender) of the Health and Safety Code
  - Conviction of one (1) misdemeanor within the last five (5) years for a related offense listed within the Health and Safety Code, Section 1798.200



## Health and Safety Code Violations 1798.200

Any of the following actions shall be considered evidence of a threat to public health and safety <u>and</u> <u>may result in denial</u>, <u>suspension</u>, <u>or revocation of a certificate or license</u>, <u>or in the placement on</u> <u>probation of a certificate or license holder under this division:</u>

- 1. Fraud in the procurement of any certificate or license.
- 2. Gross negligence.
- 3. Repeated negligent acts.
- 4. Incompetence.
- 5. The commission of any fraudulent, dishonest, or corrupt act that is substantially related to the qualifications, functions, and duties of prehospital personnel.
- 6. Conviction of any crime that is substantially related to the qualifications, functions, and duties of prehospital personnel. The record of conviction or a certified copy of the record of conviction shall be considered conclusive evidence of the conviction.
- 7. Violating or attempting to violate, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate, any provision of this division or the regulations adopted by the authority pertaining to prehospital personnel.
- 8. Violating or attempting to violate any federal or state statute or regulation that regulates narcotics, dangerous drugs, or controlled substances.
- 9. Addiction to, the excessive use of, or the misuse of, alcoholic beverages, narcotics, dangerous drugs, or controlled substances.
- 10. Functioning outside the supervision of medical control in the field care system operating at the local level, except as authorized by any other license or certification.
- 11. Demonstration of irrational behavior or occurrence of a physical disability to the extent that a reasonable and prudent person would have reasonable cause to believe that the ability to perform the duties normally expected may be impaired
- 12. Unprofessional conduct exhibited by any of the followings:
  - o Mistreatment or physical abuse of any patient resulting from excess force in excess of what a reasonable and prudent person trained in a similar capacity would use
  - o Failure to maintain confidentiality
  - o The commission of any sexually related offense under Section 290 PC
